And I am thankful to represent our portion of Lower Georgia Avenue. The community elected me to serve a two year term for 1E06 representing ~2,000 people. Our district is bounded by Georgia and Sherman from east to west and Fairmont to Barry from north to south, including the Howard Plaza Towers.

#### What are ANCs?

ANCs are your voice in DC government for matters that affect our neighborhood, such as housing/zoning, transportation, business licenses, and public amenities.

DC voters elect 345 unpaid commissioners to 2-year terms, with Georgia Ave's 1E Commission consisting of 7 single-member districts. ANC 1E is brand new as of Jan 2023.

- Better Sidewalks

   I continue to put in sidewalk improvement requests and was glad to see DDOT grind down sidewalks with trippign hazards due to water and gas meters. If you see any sidewalk issues, please submit a 311 request and flag for me!

- Howard student killed by speeding driver. I was saddened to hear that Mohamed Samura died after being hit by a driver on April 11 at the corner of Fairmont and 6th. I am working with the DC Vision Zero office to schedule a site visit to discuss safety improvements on that corner and along other stretches of Georgia Ave. I am frustrated that our mayor has not kept her promises on Vision Zero, and I will continue to push the District to improve safety for all road users. On 2/2, a man unfortunately died from an opioid overdose outside on the 700 block of Fairmont. Overdose deaths are rising in DC and are preventable. Naloxone is a life-saving medication that can be used to reverse opioid-related overdoses. I have some on hand, and I encourage neighbors to get free doses from DC. ### **Recent Successes**

- Retaining Wall fixed: After months of advocacy, DC finally fixed many of the gaps in the retaining wall behind Meyer Elementary (west side of 2500 Sherman). This was a potential danger to pedestrians, so I'm happy to see this addressed.
- asked a question at the mayor's public safety forum on 3/2 around booting and towing of vehicles frequently speeding and endangering lives. I know many in our community have had close calls with reckless drivers. I was glad to hear that the District is opening up another tow lot to manage capacity issues, and I will continue to press the mayor on booting dangerous vehicles.
- Cleaning Alley behind Fairmont: I worked with residents to document the illegal dumping and damaged vehicles in the alley behind Fairmont/Georgia. It took several follow up requests, but DPW eventually dealt with the vehicles and some of the trash.

- Holding vacant building owners
   accountable: After many months of
   follow ups with Dept of Buildings, 2623
   Sherman was marked vacant
   appropriately and taxes were
   reassessed, finally leading to
   repairs/construction for the building.
- Community cleanups: Thanks to everyone who has participated in recent months! We have collected ~15 bags of trash from cleanups this year so far.
